

**CONTRACT ADDENDUM FOR CLIENT ALCOHOL SERVICE
FAYETTEVILLE TOWN CENTER**

This contract addendum constitutes acceptance by _____ (“Client”) of the Fayetteville Town Center’s alcohol service policies and procedures for the following event.

The Fayetteville Town Center holds a *Large Attendance Facility Permit* (Article 1, Section 1.19 (21) of State of Arkansas Alcohol Beverage Control Division Regulations) issued by the State of Arkansas. Under this license, Clients have the following options regarding alcohol service for their events.

1. Host Bar

- a. All alcoholic beverages must be purchased through the Fayetteville Town Center.
- b. Client MAY NOT SELL alcoholic beverages.
- c. **Client MAY NOT provide alcoholic beverage on a SELF-SERVE basis.**
- d. Fayetteville Town Center to provide bartenders at a cost of \$50.00 per bartender, per hour for Full bar and \$35.00 per hour, per bar for Beer & Wine bar.
- e. Fayetteville Town Center will hire uniformed security through the Fayetteville Police Department at a cost of \$50.00 per officer, per hour.
- f. **Client must provide** Acrylic cups, napkins, and garnishes. The Fayetteville Town Center will provide ice.

2. Host Bar - Donated liquor- (Non-Profit Organizations Only)

- a. All alcoholic beverages must be donated by a distributor or liquor store and verified by letter of acknowledgment before event.
- b. Donated kegs will be accepted if client or donor provides a kegerator or quick-chill. The Town Center does not provide kegerators; kegs may not be served out of garbage cans.
- c. Client MAY NOT SELL alcoholic beverages.
- d. **Client MAY NOT provide alcoholic beverages on a SELF-SERVE basis.**
- e. Fayetteville Town Center to provide bartenders at a cost of \$50.00 per bartender, per hour for full bar and \$35.00 per hour, per bar for Beer & Wine bar.
- f. Fayetteville Town Center will hire uniformed security through the Fayetteville Police Department at a cost of \$50.00 per officer, per hour.
- g. **Client must provide** Acrylic cups, napkins, and garnishes. The Fayetteville Town Center will provide ice.

3. Cash Bar Service (Guest pays for own drinks)

- a. Fayetteville Town Center must purchase alcoholic beverages and provide bar service.
- b. Fayetteville Town Center to provide bartenders, \$50.00 per bartender per hour for full bar and \$35.00 per hour, per bar for Beer & Wine bar
- c. Fayetteville Town Center will hire uniformed security through the Fayetteville Police Department at a cost of \$50.00 per officer, per hour.
- d. The Fayetteville Town Center will provide d. Acrylic cups, napkins, garnishes, and ice.

4. Indemnification

Client will indemnify and hold harmless the Fayetteville Town Center, and will reimburse the Fayetteville Town Center, for any loss, expense, or damage sustained arising from any failure by Client to perform in accordance with this contract addendum, including the obligation to abide by all laws and regulations of the State of Arkansas regarding the service of alcohol.
